Chapter 2

Summary: Efforts to find a South African or International Psychiatric or Psychological Organisation or Psychiatrist or Psychologist Professional whose Organisational or Individual Professional Ethics compel them to (i) base their psychological social conflict mitigation and reduction management therapy practice based upon Ecological Reality Facts; and (ii) testify under oath to observable Ecological factual reality in any court of law.

Ecological Reality Facts being: (a) Earth is not flat; (b) Earth renewable and non-renewable resources are finite; (c) When humans breed or consume above ecological carrying capacity limits, it results in resource conflict; (d) To sustainably protect and conserve natural resources in accordance to local and national carrying capacity limits; and restrict national and international inter-cultural resource war conflict; humans must implement an international law social contract that restricts all the worlds citizens to breed and consume below ecological carrying capacity limits.

Please take notice of EoP Amicus Curiae request submitted to Dylan Storm Roof White Power War is Peace Family & AME Church Black Power War is Peace Family members; for their written permission to file an [Ecology of Peace culture](#)⁴ Amicus Curiae brief to the [AME Church v Dylan Storm Roof](#)⁵ court, for the consideration of the Judge and Jury; in their White Power v Black Power [Masonic War is Peace culture](#)⁶ matter.

As noted at [Ecology of Peace legal submissions](#)⁸, Ecology of Peace arguments and evidence are not welcome in most Masonic courts.

However should there one day be a Masonic court; or Masonic culture opponents interested in justice based upon Ecological Reality Facts rule of law; as opposed to Masonic Rule of Man Justice; and should such court be in the United States; the following would apply regarding electronic service notification of individuals relevant to the legal proceedings.

Electronic Service per email to a US citizen is lawful in terms of (I) the South African Electronic Communications and Transactions Act. 2002 (Act No. 25 of 2002) and (II) Federal Rules of Civil Procedure Rule 4(f) which allows for service “by other means not prohibited by international agreement as directed by the court,” as implemented in *Rio Properties, Inc. v. Rio Intern. Interlink*, 284 F.3d 1007 (9th Cir. 2002) which established that e-mail was an effective means of communication between parties, and that messages sent to the respondents would serve the purposes of notifying them of the pending litigation. Moreover, there is no indication that service in this manner would contravene any international agreement. Finally courts “have upheld service via e-mail, [in] cases involving e-mail addresses undisputedly connected to the defendants and that the defendants used for business purposes.” (*Ehrenfeld v. Bin Mufouz*, 2005 WL 696769 (S.D.N.Y., March 23, 2005))

Put simply maybe one day we find an impartial court of Masonic Judges and citizens capable of hearing constructive Ecology of Peace culture arguments and evidence criticism about the fuck up that is their Masonic War is Peace cult social contract religion; irrespective of whether Timothy McVeigh, Vladimir Putin and Lara Johnstone are the only village idiots on the planet who have such heretical Ecology of Peace anti-masonic beliefs, or whether there are only a handful of people on the planet who support our heretical anti-masonic beliefs. Maybe we find such a court; maybe not. We shall have to wait and see.
