Summary: Efforts to find a South African or International Psychiatric or Psychological Organisation or Psychiatrist or Psychologist Professional whose Organisational or Individual Professional Ethics compel them to (i) base their psychological social conflict mitigation and reduction management therapy practice based upon Ecological Reality Facts; and (ii) testify under oath to observable Ecological factual reality in any court of law.

Ecological Reality Facts being: (a) Earth is not flat; (b) Earth renewable and non-renewable resources are finite; (c) When humans breed or consume above ecological carrying capacity limits, it results in resource conflict; (d) To sustainably protect and conserve natural resources in accordance to local and national carrying capacity limits; and restrict national and international inter-cultural resource war conflict; humans must implement an international law social contract that restricts all the worlds citizens to breed and consume below ecological carrying capacity limits.

11 June 2001 US President & Secretary of Defense: George W Bush & Donald Rumsfeld:

Pres GW Bush & SecDef D Rumsfeld: Faked Execution & Pardon of OKC Bomber: Timothy James McVeigh: Terms of Agreement

Former President George W Bush and/or his Secretary of Defense at the time: Donald Rumsfeld is hereby requested to notify Timothy James McVeigh by email by 18 October 2015; copied to Prime Minister Vladimir Putin, Prime Minister Benjamin Netanyahu; former US Navy Judge Advocate General's Nanette Derenzi and Bruce McDonald and Former California Governor Gray Davis:

1. Confirm that Former President George W Bush and/or his Secretary of Defense at the time: Donald Rumsfeld intend to officially inform the United States people and world that the execution of Timothy James McVeigh on 11 June 2001 was faked; and the United States Government's conditional pardon terms of agreement with Timothy McVeigh.
2. If you do intend to do so; inform them by what date do you intend to do so.
3. If you do not intend to do so: honourably in writing convert Timothy McVeigh's former conditional pardon to a full unconditional pardon.

Timothy McVeigh's Faked Execution:

In late 2001; the following individuals confirmed to me to my face that Timothy McVeigh's alleged 11 June 2001 execution had been faked. Their paraphrased statements regarding Timothy McVeigh's alleged 11 June 2001 execution are as follows:

2001: Michael Martin, McVeigh's former US Special Forces Sgt; John Doe #2 of the Oklahoma City Bombing, Phoenix AZ:

'I was Timothy McVeigh's Commanding Officer in the United States Special Forces; as well as in Tim's involvement in the Oklahoma City Bombing. After the bombing I was ordered by the Army to disappear. Timothy's 11 June 2001 execution was faked; I saw Timothy on the 4th of July 2001 weekend in Kansas; after his alleged execution.' – Repeated face to face verbal conversations with Michael Martin at the Flying J Truckstop in Phoenix Arizona; Geronimo Motel, Flagstaff Arizona & while travelling in my VW Campervan.

2001: Steve West, Former US Special Forces; Secret Service Officer in the California Governors office of Governor Gray Davis: ‘Governor Gray Davis confirms that the previous statements of the California Governors Office confirming the execution of Timothy James McVeigh were incorrect. Governor Gray Davis was informed by President George Bush at their recent meeting in San Bernadino County; that in fact; Timothy McVeigh’s execution had been a hoax. Timothy McVeigh was not executed on 11 June 2001; his execution was faked. Thank you for informing the Governor’s office of this information for his verification.’ -- Repeated face to face verbal conversations with Mr. West in the Office of Governor Gray Davis.

There has been no response from yourselves to accept the Terms of Agreement offer; submitted to you on 25 July 2015; requesting that:

4. Former President George W Bush and/or his Secretary of Defense at the time: Donald Rumsfeld to confirm their intention to officially inform the United States people and world that the execution of Timothy James McVeigh on 11 June 2001 was faked; and the United States Government's conditional pardon terms of agreement with Timothy McVeigh.
5. If they did so intend: to inform Timothy McVeigh by what date they intend to do so.
6. If they did not so intend: to honourably in writing convert Timothy McVeigh's former conditional pardon to a full unconditional pardon.

Nor has there been any other alternative terms of agreement offers from President Bush. Consequently it would appear that the offered terms of agreement have been declined by President Bush.

George Magistrate Court: 5048-15: Lara Johnstone v Clive Johnstone

On 09 November 2011 I filed an application with the George Magistrates Court: [Case 5048-15: Lara Johnstone v Clive Johnstone](#); to request my father: Clive Johnstone; to request a lawyer friend of his to help me to file legal request for information to (a) Former President George W. to legally confirm or deny that he authorized Timothy McVeigh's 11 June 2001 faked execution; (b) Governor Gray Davis to legally confirm or deny that President Bush verbally confirmed with him that he had authorized Timothy McVeigh's 11 June 2001 faked execution.

I don't know if my father's lawyer friend – Karen Marshall; or anyone she may recommend – will be willing to help me to file the international legal paperwork; so I don't know whether Pres Bush and/or Governor Davis will ever receive the legal request for information documentation.

If my parents and I are unable to find a lawyer who is willing to help me to file the international legal paperwork to confirm among others the aforementioned information; I have

requested that we end our family relationship on amicable terms, say our farewells; and requested that they help me to travel to Russia; so I can depart planet earth in dignity; to be buried alone in an unmarked grave somewhere near Lake Baikal, in the Siberian wilderness.
